Youth Director – Al Steichen

- Free Throw Championship was held on March 7 at St. Pius with a turnout of 7 participants in the 10-14 year old age group – none from St. Francis. All are going to the District Championship.
- Al is coordinating the Essay Contest again this year. Prize is a \$100 savings bond for 1st, 2nd and 3rd place.
- Al asked what has been spent in the past on the Servers Pizza Party scheduled for April 4. No one could remember as it has been quite some time since the pizza party has been held. There are approximately 40 servers, so the cost should be under \$100.

Unfinished Business

- Donor Advised Fund – Chuck Mosier
 - A presentation was made of the 10 requests for funding from the Donor Advised Fund for 2010-2011. After discussion a motion was made, seconded and approved to go forward to the Fund with the Council's recommendation to support the following projects:
 - Partners in Youth – request for \$10,000 to support increasing membership in the Steubenville North Rochester Youth Conference
 - Resurrection Parish – request for \$6,000 to help establish a Helping Hands Voucher Program at each parish as part of the initiation of the parish St. Vincent DePaul Conferences
 - St. John the Evangelist Parish – request for \$5,000 to help offset the training, education and start up costs at each parish for establishing the St. Vincent DePaul Conferences.
 - St. Francis of Assisi Parish – request for partial funding of the renovations of the Parish Center Activity Room
- Pancake breakfast will be held March 20th with proceeds going to the St. Francis youth attending the Steubenville North conference.
- Received Thank You notes from Christmas Anonymous for our donation and from the RCS for our support of the Tuition Banquet.
- The wine tasting was a very successful event, approximately 107 people in attendance (last year was 116). Total receipts of approximately \$1,922 (ticket sales and gift basket raffle), with an additional \$102 received from Apollo for the wine that was sold at the
